## **Background**

- □ Due to COVID-19, PacWave20 scope reduced. Tested only 2 of 4 objectives.
  - Objective a. Communication test on November 5, 2020
  - Objective d. CATAC regional exercise
  - Other activities encouraged but at the discretion of country
- At PTWS Steering Committee (SC, Sep 2021), next PacWave (PacWave22) discussed noting PacWave20 reduced scope and findings. SC approved:
  - PTWS Task Team on PacWave Exercise to oversee.
  - PacWave22 to be conducted using same objectives and following same format and conduct as original PacWave20 (PTWS-XXVIII.1, 2019)
  - Member States consider conducting for situations based on limitations derived from COVID-19 pandemic
  - TT to compile and summarize good practices for planning, conducting, and evaluating <u>virtual</u> exercises, and include in exercise manual
  - Post-Exercise Evaluation reporting for PTWS Communications Test to be earlier to accommodate reporting to ICG/PTWS-XXX (Nov 2022)
  - TT to explore more automatic & efficient ways to compile information prior to Oct 2022



## Exercise Aim and Objectives (same as original PacWave20)

- An exercise shall be conducted with the <u>aim</u> to test PTWS tsunami service provider arrangements, and Country preparedness arrangements and operational procedures to respond and recover from a destructive tsunami.
- An exercise shall be conducted with the following <u>objectives</u>
  - Test communications from the PTWS Tsunami Service Providers to Tsunami Warning Focal Points and National Tsunami Warning Centers of Member States.
  - Test national communication and cooperation, and readiness within the country.
  - Test regional communication and cooperation between Member States.
  - Support the development of tsunami procedures and products by the Central America Tsunami Advisory Center (CATAC).




## 1. TSP Communication Test: Participation – 27 countries

- All the TSP that participated in the exercise send messages according procedures, 24 respondents reported that received the message from PTWC correctly, 11 from NWPTAC, 7 from SCSTAC and 3 from CATAC. Details are in
- The majority respondents to this question indicated that the Dummy message was received.
- Two respondents indicated that the Dummy message was not received (Mexico and Samoa).
- PTWC, NWPTAC, SCSTAC messages were received in a timely manner.
- A few countries reported large delays for unknown reasons.

#### Summary:

- 1.89% percent of countries reported received message by email.
- 2. Fax was next most common form of receipt (44%). Followed by GTS (44%)
- 3. Other method of receipt include AFTN and there is no reported message received through EMWIN.


## Did your country engage in communication and cooperation with other countries in the region for PacWave22?

The type of information shared was:


- 6 states members shared Data sharing (Seismic, sea level, etc.).


Figure 21: Engagement in communication and cooperation with other countries in the region for PacWave22.

#### **Summary:**


33% of respondents indicated national information was shared with other countries during the exercise.

Format: Live Table Top Exercise

Scenario: HTHH Volcanic Eruption and Tsunami (15 January 2022)

#### **Exercise Objectives:**

- Test the HTHH PTWC Interim Procedures and PTWS Products (IOC Circular Letter 2902), and whether the HTHH PTWS products are interpreted by PICT Member States accurately and in a timely manner, and
- 2. Test regional communication and cooperation between PICT Member States, and the value of information sharing in facilitating national tsunami alert decision-making.


## **Exercise Summary – Conduct and Format**

#### 3 Communication methods:

- Dedicated E-mail Listserv (hosted by ITIC) 63 msgs (18 unique info sharing)
- PacWave22-PICT WhatsApp group chat 89 msgs (45 unique info sharing)
- HF Radio 3 countries (Tonga, Fiji, Nauru)

#### Conduct

- Controllers simulated 4 PTWC bulletin injects sent by e-mail using a Listserv and notified via WhatsApp group too
- All information was immediately shared (no delay or review), 5 mails were not distributed because sent from an unregistered email into Listserv.
- HF Radio communication tests between Players

#### **Objective 1:**

- PTWC products good. Captured event.
   Scaled forecast heights useful for issuing warning
- Simple, easy to use. ETA useful

#### **Objective 2:**


- Countries and Observers unanimous that Info Sharing valuable
- Countries highlighted unique value of HF radio (in differing agencies within country and not tsunami-specific). Along with Satellite Phone (essential and critical, but expensive), were only comms that worked post-HTHH.


## **Exercise Summary – Cold wash, debrief 16 Nov**

#### **Exercise Outcomes – Next activities**



- HF Radio WhatsApp group still active
- Post-PacWave22-PICT, WhatsApp group used for real events
  - > 11/11/2022 : Tonga earthquake Mw 7.3
  - > **22/11/2022** : Solomon earthquake Mw 7.0
  - > 31/01/2023: Vanuatu's East EPI sub-marine volcano event (2 days ago).

Now WhatsApp Group Chat name changed to Tsunami-PICT

> PTWS WG-PICT-IX (Feb 2023) decided to formalize, standardize messaging to ensure simple, effective, and i
