1. Opening of the Meeting

Cristian Munoz-Mas (CMM), Co-Chair-Elect introduced the meeting and welcomed participants. He highlighted that this meeting required decisions to be made on some agenda items and it was necessary to comply with quorum voting requirements. 2. Monthly meeting day and time discussion for Apr - Oct 2024

The global distribution of steering group members means that meeting times will never be convenient for everyone. Each year when the 'clocks change' the SG discusses whether there is any flexibility to change meetings times. The World Clock meeting was provided for members to view how moving times globally would affect different regions and it was agreed that there was no time that would be comfortable for all regions. For the past five years the meeting has been held regularly on the 2nd Wednesday of each month, but with the increasing frequency of other zoom meetings and clashes with other group meetings, the SG was asked to consider moving the regular day in the month. The meeting by consensus agreed to change the meeting day to the 3rd Wednesday of each month, but to retain the time of the meeting.

Rules of Procedures .. MG91

Under the above Rules, decisions can only be made at one Regular Meeting (SG-OBPS) unless there is an unexpected and urgent need when an 'extraordinary' regular meeting (SG-OBPS) could be held.

In addition:

- Voting can only be used at a Regular or Extraordinary Regular Meeting (SG-OBPS)
- No email voting is permitted.
- Proxy votes are not allowed in IOC

Any voting at the OBPS February meeting was not recognized.

4. OBPS Advisory Board - proposal

CMM explained that this Advisory Board proposal had been introduced at the SG-OBPS-V by George Petihakis (Co-Chair). It had been edited in real time during the SG-OBPS-V meeting from SG comments and was now ready to be implemented following the required procedures. CMM went through the document and invited comments. Some small format edits were suggested and accepted. The Advisory Board Proposal decision had been made at SG-OBPS-V and the proposal could therefore be implemented

5. Endorsement Guideline

Jay Pearlman (JP) (Past Co-Chair) on behalf of Mark Bushnell and Juliet Hermes went through the document and explained that GOOS and OBPS had successfully piloted an endorsement process for GOOS identified practices. Taking the GOOS endorsement approach as a basis, the guideline presented here documented the process of expanding the GOOS process to include endorsement by other recognized entities. JP acknowledged that these guidelines would be the basis for endorsement now and would evolve through expected iterations as experience with implementation progressed.
