The PROCARIBE+ Project Board:

Having convened the Inception Workshop and First Project Board Meeting of the PROCARIBE+ Project, in Cartagena, Colombia, from 19-21 February 2024, with a total of 76 participants, representing 26 States and Territories (of which 17 are GEF-Eligible PROCARIBE+ countries) and 18 Organizations, and Chaired by Panama, with the Deputy Chairperson from Belize and the Rapporteur from Saint Lucia;

Taking note of all matters brought to the attention of the Project Board through the adopted meeting agenda and all materials presented thereunder, as listed in and/or referenced in Annex 1 to the present document;

Invites the Project Management and Coordination Unit (PMCU), PROCARIBE+ Co-executing Partners and Project Board Members to coordinate with other relevant initiatives including GEF projects in the CLME+ region to identify opportunities for collaboration and to seek to minimize duplication of efforts; and

Encourages all Project Board Members to remain engaged throughout the duration of the project in an effort to maximize the successful delivery of project results and to avoid delays in project implementation:

# SUB-AGENDA ITEM 10D : UPDATES TO THE PROJECT STRATEGY

Acknowledging the opening for signature of the "Memorandum of Understanding Enabling the Creation of a Coordination Mechanism to Support Integrated Ocean Governance in the Caribbean and North Brazil Shelf Large Marine Ecosystems" (the Ocean Coordination Mechanism/OCM MoU) on October 6th 2023, and (a) the MoU's provision that a minimum of 6 Intergovernmental Organizations (IGO) and 17 States and Territories sign the MoU to enable its commencement, and (b) the importance of having as many of the IGO's and States and Territories listed in Annex 1 to the OCM MoU joining the mechanism in order for the mechanism to best deliver on its mandate and objectives;

Acknowledging that 8 signatures have been collected to date;



Acknowledging the anticipated lead role of the OCM in the development of activities and outputs under PROCARIBE+ Project Components 1 and 4 relating to the OCM's mandate and functions;

*Further acknowledging that a delayed operationalization of the OCM will negatively impact the timely delivery of PROCARIBE+ project activities and outputs:* 

**10D.1.** Urgently calls upon States and Territories and the Intergovernmental Organizations listed in Annex 1 to the OCM MoU to consider signing the OCM MoU as soon as possible.

**10D.2.** Requests the PROCARIBE+ Board Members and Observers to encourage and support the efforts geared towards securing, within the shortest possible time frame, the signatures to the OCM MoU of the States and Territories listed in Annex 1 to the OCM MoU.

**10D.3.** Takes note of the proposed plans presented and discussed under PROCARIBE+ Project Board Meeting Agenda Item 10D on how to move forward with the PROCARIBE+ activities that are expected to be guided, adopted and/or endorsed by the OCM and approves "Plan A", where the OCM is to lead the PROCARIBE+ activities under Components 1 and 4 linked to the OCM, in line with the original intention stipulated in the PROCARIBE+ Project Document.

**10D.4.** Requests the PMCU to activate "Plan C", i.e. to engage the CLME+ Strategic Action Program (SAP) Interim Coordination Mechanism (ICM) and the PROCARIBE+ Project Board as interim leads for the PROCARIBE+ "OCM-related activities" until the OCM MoU commences, if the OCM MoU does not commence by the end of June 2024.

**10D.5.** Invites the ICM Secretariat to coordinate with ICM Members and PROCARIBE+ project partners to promote the signing of the OCM MoU during relevant intergovernmental regional and international events, noting that the following upcoming events may provide good opportunities for public awareness of the OCM and for securing MoU signatures:

- i. UN Environment Assembly to be held in Nairobi from 26 of February to 1st of March 2024;
- ii. Caribbean Regional Fisheries Forum (CRFM) from 6-9 March 2024 (virtual);
- iii. IV edition of ECLAC's Regional Water Dialogues in Latin America and the Caribbean to be held in Costa Rica from 11-13 March 2024;
- iv. UN Ocean Decade Conference to be held in Barcelona from 10-12 April 2024;
- v. 9th Our Ocean Conference to be held in Greece from 15-17 April 2024;
- vi. Minister's meeting of the Central American Commission of Environment and Development (CCAD) to be held in Mexico from the 15-18 April 2024;
- vii. Seventh Meeting of the Forum of the Countries of Latin America and the Caribbean on Sustainable Development to be held in Santiago de Chile from 15 to 18 April 2024;
- viii. International UN SIDS Conference to be held in Antigua and Barbuda from 27-30 May 2024;
- ix. The UN Oceans Preparatory Meeting to be held in Costa Rica from 7-8 June 2024.

**10G.1.** Approves the administrative re-allocation of the funds foreseen in the PROCARIBE+ Project Document for the OCM Secretariat from UNDP Budget Line 72100 "Contractual Services - Companies" to UNDP Budget Line 71800 "Contractual Services - Implementing Partner"

**10G.2.** Approves the recruitment of a full-time local Operations and Finance Officer.

**10G.3.** Requests UNOPS to fully support and expedite PMCU recruitment processes to urgently enhance the PMCU Human Resources capacity.
