











TSUNAMI READY RECOGNITION PROGRAMME - FIJI

Introduction

- The Seismology Unit Mineral Resources Department is the National Tsunami Warning center for Fiji.
- Since 2018, the Seismology unit takes lead role in commemoration of World Tsunami Awareness Day. Last year was a bit different as Fiji launched its first Tsunami Ready Community under the UNESCO/IOC Tsunami Ready Recognition Programme.






- Final indicator for TRRP

Challenges

- FIRST TIME EXPERIENCE- TIME MANAGEMENT
- Scheduling Brief Meetings with communities and Local Govt Officials-Briefing on the project, Plans, Individual's functions and support for Exercise.
- Need to have timeline/Milestone deadlines for signed paperwork
- Need to review:
 - NTRB (National Tsunami Ready Board) review of Terms of Ref, members
 - TRLC (Tsunami Ready Local Committee) review of ToR, members
 - NTRB, Letter of Intent should be sent as soon as known don't wait for last moment
 - TR Application -
 - NTRB should meet to evaluate TR Application (confirm that all indicators satisfied)
 - Must be signed fully
 - Put supporting docs into google Drive Folder use file naming covention

Way Forward

- Create a guideline to be used by NGO's in Fijian context.
- Implementing colored vests during exercise for different players.
- Identify how key stakeholders (NGO's) can assist along the way rather than MRD (National Tsunami Warning Center) and National Disaster Management Office (NDMO).
