Subject: United Nations Decade of Ocean Science for Sustainable Development (2021–2030): Updates on Ocean Decade Implementation including Call for Applications for the 2nd Edition of the Mario Ruivo Memorial Lecture and Call for Nominations for the Ocean Decade Gender Expert Working Group

## Launch of the Vision 2030 Outcomes Report

Based on the outcomes of the parallel sessions of the 2024 Ocean Decade Conference that deliberated on the results of the Ocean Decade Vision 2030 process, the launch of 'The Barcelona Statement' on 12 April 2024, and subsequent consultations with the Decade Advisory Board during its Meeting No. 02/2024 and with Member States during the 57th session of the Executive Council, the consolidated report of the Vision 2030 process has been launched, entitled 'Ambition, Action, Impact: the Ocean Decade Pathway to 2030'. This report summarizes the strategic ambition statement that was developed for each of the Ocean Decade Challenges through the Vision 2030 process and includes a list of priority actions to guide the work of the Ocean Decade in coming years.

## **Update on Ocean Decade Mid-Term Evaluation**

In accordance with IOC Resolution EC-57/1, a detailed Terms of Reference for the Ocean Decade Mid-Term Evaluation was developed and advertised between 23 August and 15 September 2024. Based on a competitive tendering process, INOMER Business Consulting and Services has been engaged by UNESCO's Internal Oversight Service (IOS) as the expert evaluators for this process. The evaluation process formally commenced on 7 October 2024 and as described in IOC Resolution EC-57/1 will involve comprehensive consultation with Member States, National Decade Committees and other relevant stakeholders. The details of the consultation process, which will take place between November 2024 and February 2025 are being finalized in consultation with IOS and the expert evaluation team and consultation activities will include individual interviews, focus groups and surveys.
