TOWS-WG XVII Key Recommendations - (TT-TWO)

Detection, Warning and Dissemination

TT-TWO

- TT-TWO and TT-DMP to develop KPIs for the relevant sections of the ODTP
- to review existing Tsunami SOPs and develop general guidelines on SOPs to warn for volcano generated tsunamis
- TT-TWO Ad Hoc Team on Meteotsunamis in consultation with WMO and IUGG JTC to review the term and definition of meteotsunami
- Identify key indicators for each ICG to monitor network status and data quality, aligning with tsunami warning needs in the ODTP-RDIP (IOC/2023/TS/180).
- develop a global CAP template for TSPs to facilitate exchange of bulletins
- evaluate tsunami probabilistic forecasting methods and provide advice to TSPs and NTWCs in all ICGs;

ICGs(TSPs)

- TSPs to trial and operationalise
 dissemination of maritime bulletins to
 respective NAVAREA operators
- TSPs may need to provide services for TGVs that may impact several MS
- Multi-purpose sea level monitoring stations to support MHEWS
- Use Exercises and Communication tests for monitoring data availability and quality
- Sharing of info on deployment of new technologies to monitor sea level variations
- consider performing exercises outside of working hours, in particular during the night;
- TSPs monitor sea level and seismic networks at least biannually, reporting to Secretariat on the status

Secretariat

- Distribute report on Monitoring and warning for TGVs including the list of tsunamigenic volcanoes to Member States and Volcano Observatories IOC/2024/TS/183
- Initiate consideration of whether TSPs may need to provide new services for TGVs
- advise all Member States via Circular Letter (CL) that TSP fax transmissions will cease from 6 months of CL date, unless Member States advise within 3 months that fax is the only medium to receive.
- Develop reporting mechanism on
 Ocean Decade projects and against
 ODTP-RDIP KPIs aligning with Global
 KPI Framework

- Closer collaboration between IOC/UNESCO and WMO MHEWS, UN EW4ALL, CIFI
- Review the roles and responsibilities for Meteo-tsunamis JCB
- Extends the tenure of TOWS-WG and its Task Teams
